The unit owner is financially responsible for any damage to the plantings, irrigation system (sprinkler heads, underground piping etc.), building structure, walkways, driveway, and common areas. The property maintenance manager must review any request which may affect irrigation, prior to the start date.

The Unit Owners that make changes to their property prior to receiving notification of approval, will receive a violation notice. A fine may be issued, and they may be required to modify the unapproved work.
